Promotion of ASIs to the post of SIs(GE) for the year from 2014 to 2019 could not be ordered for want of Seniority Lists due to the disputes between the Police Personnel recruited through the Armed Police Battalion and the Police Personnel recruited directly to the District Armed Reserve Camps, regarding the criteria for fixation of Seniority in Local Police. As a measure to resolve this, the Government had issued orders vide GO(MS) 37/2015/ Home dated 26.02.2015 and GO(P)28/2017/Home dated 16/02/2017. Aggrieved by this, some affected parties approached the Kerala Administrative Tribunal by filing OAs.The Seniority disputes between the contending parties are yet to be finally settled. However, in order to fill up the vacancies, the Department requested the Hon'ble High Court of Kerala to issue necessary orders as a remedial measure to publish the Seniority Lists of Police Personnel from the rank of CPO to SI who were recruited prior to 17/07/1986 directly in the Armed Reserve and Armed Police Battalion on the basis of GO(P) 125/1980 as per the provisions of GO(P)28/2017/Home dated 16/02/2017, and to publish the Seniority Lists of Police personnel from the rank of SCPO to SI those who were recruited after 16/07/1986 in accordance with GO(P) 33/89/Home dated 10.03.1989 and to effect promotions to the existing vacancies in the cadres subject to the final order of the court in OP(KAT) 506/2017.

Accordingly the Hon'ble Kerala High Court passed an order on 31.10.2018 permitting the official respondents to effect promotions to the vacant categories subject to the outcome of the original petitions. For the above purpose, the State Police Chief as per PHQ message read as 2'nd paper above issued directions to publish the Seniority Lists by modifying the positions of eligible PCs those who were inducted into the force prior to 17/07/1986 in the list prepared as per GO(P)33/89/Home dated 10.03.1989 subject to the outcome of the original petitions pending before the Hon'ble Court. Accordingly, a Partially Modified List of ASIs (GE) was published from this office vide Order referred as 4th above only for the purpose of effecting promotion to the existing vacancies. Further to that, a DPB was convened for the preparation of Select List of ASIs (GE) fit for promotion

as SIs for the vacancies from 01.04.2014 to 31.12.2019 in Kochi Range. The Select List so prepared has been approved by the State Police Chief vide PHQ order read 5'th paper above.

In view of the above, 31 seniormost ASIs of this unit who have been included in the Select List and fit for promotion as SIs(GE) as per the PHQ order read as 5'th paper above and still in service are provisionally promoted as SIs(GE) vide the reference 6'th cited with immediate effect and are posted to the units noted against

The promoted Personnel will have to undergo the qualifying course, if not already attended and are liable to be reverted if they fail to attend/complete the course. The promoted officers will be on probation for a period of one year



on duty within a continuous period of two years of service. Officers concerned are directed to relieve the promoted officers forthwith and report compliance.
